 2. The above results were reviewed by the Audit Committee and approved by the Board of Directors in their meeting held on 23rd February, 2022 and the Statutory Auditors of the Company have carried out 'Limited Review' of the same.
 3. The Company has been continuously incurring losses over last several years and its net worth stands fully eroded. Due to a slowdown in demand by user industries, lack of working capital funding and volatility of aluminium price the Company was not able to utilize its production capacity optimally. The management feels that the demand would revive considering various incentive packages announced by the Government. The management also expects to convince the lenders, who have approached the NCLT for recovery of their dues, for a pre-accepted resolution plan and accordingly expects to arrive at a settlement with lenders in due course of time and believes that it is appropriate to prepare the financial statements on a going concern basis.
